The Budget Meeting #4 of the Board of County Commissioners was held on July 22, 2025 at 1:00 P.M. in the BoCC Meeting Room at the Levy County Government Center.

CALL TO ORDER: Madam Chair Mills reconvened the meeting at 1:00 P.M.

Business or Informational Items

1. Requesting the Levy County Board of County Commissioners to receive a presentation on the Ad Valorem Tax Analysis and Proposed Budget. *(Audio 2:00)*

- **Presenter:** Jason Rivera, Aclarian, Levy County Budget Officer
 - **Discussion:** This proposed Budget includes all requests that were submitted; the BoCC will give direction to staff about requested changes to the budget following the presentation. \$10.2 million increase to budget over 2025.

2. Requesting the Levy County Board of County Commissioners to set (1) a tentative budget; and (2) a proposed millage rate for the purpose of providing notice and setting the public hearings required by Section 200.065, Florida Statutes. *(Audio 11:15)*

- **Presenter:** Mary-Ellen Harper, County Manager
- **Discussion:** This vote does NOT approve the tentative budget or proposed millage, but rather it gives staff the information that must be inserted in the 9/9/25 Tentative and Proposed Resolutions and the notice for that 9/9/25 meeting.
- Commissioners gave direction to staff to come back at the August 19, 2025 with proposed changes to consider:
 - Present budget reflecting millage at 9.0
 - Assessments to be considered at 50% funding model option.
 - 3% COLA Employee Increase
 - 100% County Contribution to Individual Employee Healthcare Plans
 - Staff to Provide Budget Reduction Considerations
- First public hearing set for 9/9/25, at 5:00pm. Adopting tentative budget and tentative millage rate. Will be advertised on TRIM Notice.
- Second public hearing set for 9/23/25, at 5:01pm. Adopting final budget and final millage rate. Will be advertised in the newspaper.
