- Discussion: Levy County to provide permitting services for Town of Bronson. Town Manager, Amanda Huber addressed BoCC as wanting better convenience and consistency for residents and contractors alike. Bronson has budget constraints and this action would benefit all parties. Discussion by the Commissioners indicated concern that this agreement may open up the County to providing services for all municipalities creating a workflow strain. PBO, Bo Cox assured the BoCC that he and his staff could handle the Bronson agreement as Bronson does not have a lot of activity taking place. Commissioners also pointed out if at any time this didn't work out the agreement gave all parties 30 days to give notice of termination. Commissioners made no motions, so Madam Chair Mills passed the gavel to Vice Chair Hodge and made the motion to approve the Interlocal Agreement. Comm. Hodge, as acting Chairman seconded the motion and the BoCC held a vote on the item.
